- 1. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03,2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. ## 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- A. The following documents must be submitted by the bidders failing which the bid is liable to be rejected.
  - 1. PAN card
  - 2. GST registration
  - 3. Acknowlegement of IT return for AY 2023-24 or later
  - 4. Experience of supplying vehicles on hired basis for 2 years (minimum)
  - 5. Self declaration of accepting all the terms and conditions of this bid.
  - 6. Proof of address in Jorhat or Sivsagar district of Assam.
  - 7. Dedicated/toll Free Telephone No. for Service Support.
  - 8. Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
- B. Special Terms and Conditions
- 1. The quantity of vehicles required as mentioned in the scope of work is purely tentative and the actual re quirement may decrease or increase from the tentative number depending upon the requirement and availability of fund. The actual requirement will be informed to the service provider before every tour.
- 2. The terms and conditions provided in the scope of work of this bid document forms and integral part of the bid.
- 2. Bidders are required to upload a self declaration of accepting all the terms and conditions of this tender.
- 3.Irrespective of the number of vehicles, outstation nights and number of tour days etc. as indicated in the bid document as required, the actual payment will be considered only on the basis of vehicles/services use d by the institute.
- 4. The payment will be made only for the actual vehicles used. Mere placing the contract to the successful bidder does not make the supplier eligible to claim the payment for all the quantities mentioned in the cont ract.
- 5. The Service Provider must submit the bills of individual items of events or hiring within one week of completion of the assigned task, so as to facilitate expedited payment.
- 6. The Service Provider/Driver shall not have the right to call an end to the duty.
- 7. The service provider will ensure that the bills are submitted within a week after completion of every tour
- 8. Director, ICFRE-RFRI reserves the right to hold or terminate the contract at any time, if necessary.
- 9. This Bid is also governed by the General Terms and Conditions, conditons stipulated in Bid and Service L evel Agreement specific to this Service as provided in the GeM-Marketplace. However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Condition. Similarly, the Buyer A dded Bid Specific Terms and Conditions will over ride any contradictions with the General Terms and Conditions and Service Level Agreement.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
